
To consider, and if thought fit, to pass, with or without modification(s), the following resolution as a Special Resolution:

EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013:

Item No. 1 relating to appointment of Shri Srirama Madakasira Narasimha Swamy (DIN: 10367727) as an independent director of the Company for a term of five consecutive years w.e.f. 1 August 2024.

With a view to broad base the Board with professionals from diverse background, the Board of Directors, at their meeting held on 22 July 2024, subject to the approval of shareholders and on the recommendation of the Nomination and Remuneration Committee (NRC) which basis the evaluation of skills, knowledge and experience, appointed Shri Srirama Madakasira Narasimha Swamy (DIN: 10367727) as an Additional and Independent Director for a term of 5 (five) consecutive years commencing from 01 August 2024 to 31 July 2029.
